The presentation will focus on the budgetary aspects of the 2028–2034 MFF and the sectoral proposals related to the CAP. It will examine both the overall budget and specific allocations, taking also into account the adjustments proposed in recent months by Commission President Ursula von der Leyen. It will also outline the implications of these budgetary elements for the implementation of the CAP, including at Member State level, as well as the different co-financing rates and provisions for crisis management.
- 9:13 – 9:21 **The governance of the 2028–2034 Common Agricultural Policy**
Mr Alan MATTHEWS, Trinity College (Ireland)
The presentation will provide an overview of the implications of the 2028–2034 MFF and the accompanying sectoral legislative proposals for the future governance of the CAP. It will consider the proposed restructuring of EU funds, its impact on CAP interventions, and the increased flexibility granted to Member States in making key decisions on how CAP measures operate. It will also outline possible adjustments to improve these proposals, particularly with a view to preserving the common nature of

agricultural policy and preventing its renationalisation. In this context, it will examine the role of the steering mechanism included in the CAP proposal.
